Boarding Agreement

This pet boarding agreement is made and entered into by and between Country Paws Play & Stay and _____ (pet owner) on this date _____. This agreement will apply to any and all visits made by the above owner's pet(s) to Country Paws Play & stay.

1.) **Services:** Country Paws Play & Stay offers boarding, grooming and doggie daycare. The pet owner allows Country Paws Play & Stay to provide these above said services for their pet(s) on an "as needed" basis in their facility located in Hollywood, SC. _____

2.) **Payment:** The pet owner agrees to pay for all services in full upon their pet's pick up date. Pet owner agrees to notify Country Paws Play & Stay in advance if there is any change in the date or time that their pet is to be picked up. Pet owner is also to let Country Paws Play & Stay know in advance if someone other than themselves is going to pick their pet(s) up. No animal(s) will be released until all performed services have been financially compensated for in full. _____

3.) **Our Prices:**

4.) **Holiday Boarding:** The pet owner understands that a non-refundable deposit may be required in order to hold any boarding dates on/around any major holidays. These holidays consist of Easter, July 4th, Labor Day, Memorial Day, Thanksgiving, Christmas and New Years. Pet owner understands that Country Paws Play & Stay will have certain hours of operation on these said holidays as well. There will be NO daycare services available on any major holidays. _____

5.) **Health & Vaccinations:** The pet owner hereby certifies that their pet(s) is/are in good health and have not been ill with any communicable conditions in the last 30 days. Country Paws Play & stay reserves the right to refuse any pet at check-in that

appears sick, injured, in pain or displays behavior that may jeopardize the health and safety of other animals or our staff. The pet owner agrees to show documentation that their pet is current on all required vaccinations - Rabies, DHPP and Bordetella. Canine influenza is not required, but highly recommended. The pet owner also understands that Country Paws Play & Stay enforces a flea-free policy. The pet owner agrees that if their pet is found to have fleas upon arrival or during their stay, Country Paws Play & Stay may provide the appropriate treatment needed (Capstar, \$10) at the owner's expense. The pet owner also understands that all pets staying at Country Paws Play & Stay are fully vaccinated, however, it is still possible for animals to become ill. Pet owner acknowledges that this is not due to any circumstance or condition at Country Paws Play & Stay and agrees to not hold the said facility liable in the event their pet becomes ill during or after their stay.

6.) **Kennel Cough:** Country Paws Play & Stay has taken every step possible to insure a clean and safe environment for all pets, however, kennel cough (Infectious Tracheobronchitis) is highly contagious, even to vaccinated pets. The pet owner understands that the kennel cough vaccine does not protect against every possible strain of the upper-respiratory disease. The incubation period of this virus can be anywhere from 3-10 days, in which a dog shows no signs of the disease, but is still contagious. Unfortunately, this is usually when it is spread. The pet owner fully understands that kennel cough is an airborne virus that can be present anywhere, such as their own back yard, the dog park, the vet's office, other kennels, etc. Although we do our very best to keep a spotless kennel, we can no more prevent the possibility of a pet contracting kennel cough than a local school can prevent a child from passing along a cold or the flu.

7.) **Emergency Medical Treatment:** The pet owner understands that in the unlikely event their pet becomes ill or injured while at Country Paws Play & Stay, or if their pet has a pre-existing condition which is aggravated by their stay, and requires professional attention, we will attempt to notify them or their emergency contact at the phone numbers they have provided. Country Paws Play & Stay, at our sole discretion, may engage the services of a veterinarian clinic of our choice in the event of an emergency, which will be at the pet owner's additional expense. The pet owner agrees to allow Country Paws Play & Stay administer any veterinarian prescribed medications to their pet, if deemed necessary. If we are unable to reach the pet owner or their emergency contact in this event then Country Paws Play & Stay will make all healthcare decisions for the said pet based on the recommendations of available professionals. In the unfortunate event that the pet owner's animal passes away at Country Paws Play & Stay, then we have made arrangements with a local vet to keep the said pet in their facility until the pet owner returns.

8.) **Natural Disaster/Emergency Evacuation :** In a natural disaster or emergency evacuation, every effort will be made to contact the pet owner or their emergency contact to retrieve their pet(s). The pet owner agrees that Country Paws Play & Stay, at its sole discretion, is authorized to transport and/or make temporary alternative arrangements to house and care for all pets until the owner or emergency contact can

be reached or until the pet can be picked up. On the other hand, the pet owner also understands that it may not always be possible to safely evacuate their pet(s). The pet owner is aware of the risk for injury or possibly even death in the event of a natural disaster, such as a hurricane, tornado, flood, etc. _____

9.) **Group Activity:** The pet owner acknowledges that while their pet is staying at Country Paws Play & Stay, the said pet will come into contact with other animals. Every effort will be made to ensure the safety of our guests, but the pet owner understands that in the event their pet is injured by another animal in our care, the pet owner releases Country Paws Play & Stay from any liability for such injury. However, if the pet owner's pet injures another animal in our care, then the pet owner agrees that they will be solely responsible for any injury to the other animal(s) as well as their own pet, they agree to cover any and all vet expenses, and they release Country Paws Play & Stay from any liability for such injury. _____

10.) **Pet Behavior:** The pet owner agrees that if their pet becomes aggressive, destructive or acts in any manner that puts Country Paws Play & Stay and our employees in any apparent danger, we will attempt to notify them or their emergency contact to make other arrangements for their pet. The pet owner is aware that any pets kenneled together are only from the same household, no exceptions. The pet owner assumes all responsibility for any aggressive behavior, fighting or injury that one pet may inflict upon another while they are together. At our discretion, Country Paws Play & Stay reserves the right to separate any pets who are boarding together if their safety is at risk. If the pet owner's animals are not compatible boarding in the same kennel then the pet owner will be billed accordingly and responsible for the cost of more than one kennel. _____

11.) **Photos & Video Release:** The pet owner **DOES** or **DOES NOT** allow Country Paws Play & Stay, our representatives and employees to use their pet's name and any images or likeness of their pet taken while staying at Country Paws Play & Stay, in any form or format, for use at any time, in any media, marketing, advertising, illustration, trade or promotional material. _____

12.) **Personal Property:** The pet owner understands that Country Paws Play & Stay, our representatives and employees will not be liable or responsible for any lost, stolen or damaged personal property belonging to either the pet or the pet owner. The pet owner is also aware that their pet's collar may be removed while at our facility to prevent any possible injuries. _____

13.) **Abandonment:** The pet owner agrees that if their pet is not picked up within ten (10) calendar days after the scheduled pick up date, or the pet owner refuses to pay agreed upon charges, then the pet shall be deemed to be abandoned. The pet owner acknowledges that in the event their pet is considered abandoned, there will also be a re-homing fee of \$100 at the expense of the pet owner. Once a pet is clarified abandoned, Country Paws Play & Stay reserves the right to make any and all decisions for that said pet in regards to daily care, living arrangements, etc. Country

Paws Play & Stay will thereby be the pet's new owner. _____

The pet owner agrees that they have read this entire agreement, they have had the opportunity to thoroughly discuss it with Country Paws Play & Stay to their complete satisfaction and they agree to its terms.
